

Since 2005, Georgia Asylum and Immigration Network (GAIN) has helped immigrant victims of crime and persecution find safety, freedom, and opportunity in the United States. We recruit, train, and mentor volunteer attorneys to ensure that asylum-seekers and immigrant victims of human trafficking, domestic violence, sexual assault, and other crimes have access to quality legal representation for their immigration matters.

Through direct representation and pro bono referrals, we provide critical access to legal services for people from more than 100 countries to help thousands of men, women, and children rebuild their lives.

Pablo's Story

Pablo* is a 20-year-old man from Honduras who was physically abused by his mother and stepfather because they believed him to be gay. He was often made to sleep outside or in the outhouse, and his own parents sold him to a predator who followed him to multiple cities—he could not escape. After surviving repeated sexual abuse, Pablo fled to the United States and filed for asylum. Pablo now has the legal assistance he needs to live a life free from persecution. Although he has suffered tremendously, Pablo is learning to thrive and is thankful for the support he has received from GAIN.

ASYLUM

GAIN's Asylum Program assists immigrants fleeing persecution abroad by providing legal representation for their asylum cases.

In 2018, GAIN saw new challenges in immigration policy, most notably a policy change which creates greater hurdles for domestic violence survivors seeking asylum in the U.S.

Throughout the year, GAIN faced immigration policy changes with **courage** and **compassion** along with our **community** who continued to support Georgia's diverse immigrant population.



VICTIMS OF VIOLENCE

GAIN's Victims of Violence Program helps immigrants who have been victims of crime in the U.S. These clients include victims of human trafficking, domestic violence, sexual abuse, and other crimes. When immigrant survivors have access to quality legal representation for their immigration matters, they are able to build a life free from abuse.

TYPES OF IMMIGRATION RELIEF

- T-visas for victims of human trafficking
- U-visas for victims of crimes committed within the U.S.
- VAWA Self-Petitions for victims of crimes committed by a U.S. citizen or permanent resident spouse

Women & Girls





At GAIN, we know that a little goes a long way!

Since our founding in 2005 as a small project created by Georgia's pro bono leaders, our people have always been our strength. GAIN's volunteer force of attorneys serves clients across the state, ensuring that our programs remain free to our clients. With a people-powered model like ours, we have kept our costs low, and 75% of our 2018 expenses funded personnel costs.



Our work is made possible by donors and supporting organizations. In 2018, we increased our federal funding by 116% to \$372,214 and raised more money than ever before at the Go Formal For Freedom Gala with a net income of \$181,186. Our individual donors made our first annual fund appeal a success, increasing individual and Board donations by 87% from 2017 to total \$73,226. This funded GAIN's biggest year yet—our first full year with our own office space, our first year with more than one half million dollars in revenue, and a near-doubling of our staff—all of which allowed us to enhance our services for immigrant victims of crime and persecution.
