BY SCREENING REFERRED CASES, PLACING THEM WITH TRAINED VOLUNTEER ATTORNEYS AND PROVIDING ADVICE AND MENTORSHIP, THE ORGANIZATION SUSTAINS A MECHANISM FOR ASSISTING HUNDREDS OF CLIENTS EACH YEAR.
