The Georgia Asylum and Immigration Network (GAIN), a nonprofit organization that provides free immigration legal services to asylum seekers and immigrant survivors of crime, is seeking a full-time immigration attorney for its Asylum Program. The attorney will be responsible for providing legal services to immigrant survivors, with a particular focus on asylum-seekers.
